On December 15, 2014, NewStar TRS I LLC ("NewStar TRS"), a subsidiary of NewStar Financial, Inc. (the "Company"), entered into an amendment to its total return swap ("TRS") with Citibank, N.A. ("Citibank") pursuant to an amended and restated Confirmation Letter Agreement by and between NewStar TRS and Citibank (the "Amendment"). The Amendment increased the maximum notional amount of the TRS from \$75,000,000 to \$125,000,000. The foregoing description of the Amendment does not purport to be complete and is qualified in its entirety by reference to the full text of the Amendment which has been filed with this Current Report on Form 8-K as Exhibit 10.1.
