Item 1.01. Entry into a Material Definitive Agreement.

First Amendment to the Amalgamation Agreement

On February 17, 2015, PartnerRe Ltd. (“PartnerRe” or the “Company”), a Bermuda exempted company, and AXIS Capital Holdings Limited, a Bermuda exempted company (“AXIS”), entered into the First Amendment to the Agreement and Plan of Amalgamation (the “Amendment”), amending the Agreement and Plan of Amalgamation, dated as of January 25, 2015 (the “Amalgamation Agreement”), previously entered into by and between PartnerRe and AXIS. Pursuant to the Amalgamation Agreement, as amended by the Amendment, subject to the satisfaction or waiver of certain conditions, PartnerRe will amalgamate with AXIS (the “Amalgamation”) and the combined company will continue as a Bermuda exempted company (the “Amalgamated Company”). In addition to certain administrative clarifications, the Amendment modifies an interim operating covenant of the parties.

The foregoing description of the Amendment and the Amalgamation Agreement does not purport to be complete and is qualified in its entirety by reference to the full text of the Amendment, which is attached hereto as Exhibit 2.1 and incorporated by reference herein, and the Amalgamation Agreement, which was filed as Exhibit 2.1 to PartnerRe’s Current Report on Form 8-K filed on January 29, 2015 and is incorporated by reference herein.
